STALLION SERVICE CONTRACT

WITNESS THIS AGREEMENT this _____ day of _____, 20____, between Rockin' P Ranches, hereinafter referred to as "Ranch", and _____, hereinafter referred to as "Mare Owner". Whereas, mare owner is the owner or lessee of a certain registered mare having the registered name of: _____ with the AQHA registry. Registration No. _____, foaled in _____, and Whereas, mare owner wishes to breed said mare as above described to the stallion: Plenty Roan Ambrose .

BOOKING AND STALLION FEES

(A) Mare owner agrees to pay a non-refundable booking fee of \$400 to reserve a breeding for the year 20____, which shall be applied towards the total Stallion breeding fee of \$800 .

(B) Fees apply in addition to the Stallion breeding fee accordingly as follows. Please check the appropriate option:

_____ Out of state or artificially inseminating mares that require shipped semen: A sum of \$500 includes vet collection, handling/ service fees, plus semen shipment in order for Ranch to breed the mare belonging to mare owner as above described. Fees must be paid in full prior to semen shipment.

_____ Live covered mares on Ranch: additional fees stated below must be paid in full upon pick up of the mare from Ranch that has been bred.

LIVE MARE CARE RANCH FEES

(A) Mare owner agrees to pay Ranch the sum of \$10.00 per day for dry mares, and \$13.00 per day for wet mares (with foal at side). This amount will be charged per calendar day, in which the mare is in the custody or control of Ranch.

(B) Mare owner agrees to pay a one-time Stallion handling service fee of \$100 for the current breeding season.

(C) Upon birth of a "live foal," remaining Stallion breeding fee of \$400 is due no later than the end of the current breeding season or July 30th. A stallion breeding certificate shall not be issued until all expenses are paid. Mare owner agrees to pay all charges when due. Ranch shall have a lien against the mare and/or any foal at side, which is the subject of the agreement until such time as any and all charges are paid in full.

GENERAL CONDITIONS

This contract is a "live foal" guarantee. "Live foal" is herein defined as a newborn foal which stands and nurses without assistance for 72 hours. If the foal is born dead, or if the mare does not otherwise carry to term, there shall be a return privilege for the following breeding season only if the notification procedures as set forth below are followed.

(A) It must be evidenced by a written statement from a licensed vet dated within one week from the date of death of the fetus, or in the alternative, a sworn statement from said vet that the mare is no longer in foal and the date of fetus loss is unknown. Mare owner shall contact stallion owner of reported loss of fetus, foal or the mare.

(B) In the event of the death of the above named stallion, frozen semen, if available, will be issued to service the mare. No money shall be refunded to the mare owner except the booking fee if the mare has not been bred. In the event of the stallion's death prior to the delivery of a live foal, the live foal guarantee as above described shall become null and void. Should the mare die prior to breeding, no fees or charges are refundable. However, an approved mare may be substituted.

ROCKIN' P RANCHES

Ranch shall not be liable for any sickness, disease, estray, theft, death, or injury which may be suffered by the mare and/or foal at side during breeding or boarding of the mare and/or foal. In no event shall Ranch be held liable to mare owner for equine death or injury.

Mares that are not halter broken and/or cannot be hobbled will not be accepted. Mare owner understands that the mare may be tranquilized for breeding purposes if deemed necessary by Ranch. Mare owner further authorizes breeding by artificial insemination if deemed appropriate by Ranch, and agrees to pay any veterinary charges arising in connection therewith.

It is understood that the breeding season for Ranch commences on March 1st of the calendar year and terminates July 30th of the same calendar year. Mares who do not come into season or are not settled within said breeding season shall be carried over to the following year. In the event mare owner elects to rebreed during the following breeding season, mare owner agrees to pay any increase in the stallion breeding fee or mare care fee if applicable.

Mare owner assumes all responsibility for pregnancy testing. It is highly recommended but not mandatory that mare owner schedules a licensed vet to perform an ultrasound/pregnancy check on said bred mare within forty-five days from the date of last breeding and report pregnancy check to Ranch if mare is not in foal.

Sale of the mare by mare owner to another party will terminate the live foal guarantee as set forth above and described in this contract. This breeding is non-transferrable.

This contract represents the entire agreement between the parties. No other agreements, promises, or representations, verbal or implied, are included herein unless specifically stated in this written agreement. This contract is made and entered into in the state of Oregon, and shall be enforced and interpreted in accordance with the laws of said State. Additional agreements should be separately initialed by each party.
